### 6. Accidental Release Measures

<b>Containment</b>	If greater than 100kg is stored, secondary containment and emergency plans to manage any potential spills must be in place. In all cases design storage to prevent discharge to storm water.
<b>Emergency procedures</b>	In the event of spillage alert the fire brigade to location and give brief description of hazard. Stop the source of the leak, if safe to do so. ### 7. Storage & Handling

#### Engineering Controls

### 11. Toxicological Information

#### Summary

IF SWALLOWED: irritation of the mouth, throat and gastrointestinal tract. Harmful if swallowed. May cause a burning sensation in the mouth and throat.

IF IN EYES: may cause stinging, reddening and watering of the eyes. Lengthy exposures or delayed treatment may cause permanent eye damage.

IF ON SKIN: may cause irritation. Symptoms may include, itchiness and reddening of the skin. Sensitised individuals may experience an allergic skin reaction (copper sulphate).

IF INHALED: dust may be irritating to the respiratory tract. Symptoms may include headaches, irritation of the nose and throat and increased secretion of mucous.

This substance is considered very toxic towards aquatic organisms with long lasting effects, harmful in the soil environment and toxic towards terrestrial vertebrates.
